On May 10, 2018, you submitted a pleading to the Board's Washington Regional Office titled Reopening an Appeal Dismissed Without Prejudice. That office referred your pleading to this office as a petition for review of the administrative judge's April 6, 2018 initial decision in the above-referenced matter. The Board's regulation at 5 C.F.R. § 1201.114(h) provides that a petition for review, a cross petition for review, or a response to a petition for review, whether computer generated, typed, or handwritten, is limited to 30 pages or 7500 words, whichever is less. It further provides that computer generated and typed pleadings must use no less than 12 point typeface and 1-inch margins and must be double spaced and only use one side of a page. The length limitation is exclusive of any table of contents, table of authorities, attachments, and certificate of service. A request to submit any pleading in excess of the limits described above must be submitted in accordance with 5 C.F.R. § 1201.114(h) and will be granted only in exceptional circumstances.

Your electronic submission consists of the following: an e-Appeal summary page; an e-Appeal table of contents; an e-Appeal online interview; a nearly 18-page petition for review that is less than double spaced with portions of text that appear to be less than 12 point typeface; an appendix of exhibits A-KK*; and an e-Appeal certificate of service.

Your petition for review, exclusive of the e-Appeal summary page, e-Appeal table of contents, e-Appeal online interview, appendix of exhibits, and certificate of service, does not comply with 5 C.F.R. § 1201.114(h) because it is less than double spaced and

portions appear to contain less than 12 point typeface. Accordingly, your petition for review is rejected and will be returned to you via separate email. You may perfect your petition for review by submitting a petition that complies with 5 C.F.R. § 1201.114 on or before **May 18, 2018**. If a petition is not filed by that date, the administrative judge's April 6, 2018 initial decision will remain the final decision of the Board and any further right of appeal must then be exercised in accordance with the provisions as stated in that initial decision.
